2. Past due balances are assessed a finance charge of 1 1/2% per month which is equal to an annual percentage rate of 18% or the maximum rate authorized by law whichever is lowest. Any past due accounts will be placed on credit hold.
3. Non-current accounts will be placed on a cash basis at our option unless arrangements have been made in advance of the sale for possible extended terms.
4. In the event any account is not paid when due and that legal action is commenced, the prevailing party shall be entitled to its reasonable attorney fees and court costs, including any cost of appeal. Parties hereby agree that if any suit or action is brought to enforce any part of terms of sale herein, venue of said suit should be in the District Court of the State of Ohio.
5. Signature by you or your authorized representative on this credit application form is presumed to establish your acceptance of the terms and conditions set forth herein, without exception, and to your agreement to comply with said terms.
6. It is expressly agreed that at the sole discretion of Ansonia Lumber Company if this account is delinquent and is referred to a third party or parties for collection, all additional costs will be borne by the signee.
